REPORT OF THE INSPECTION COMMITTEE


An Inspection Committee comprising Dr. Randeep Rana , Dr. Anju, and Dr Kavita visited South Point Degree College, Sonapat on 10-7-23 regarding grant of Extension in provisional affiliation for MA English 2nd Year Course and its Continuation in 1st year course with an intake of 60 seats w.e.f the session 2023-24.

The following are the observations of the committee:


1. The college has ample space and infrastructure for the existing course. The college building houses a Principal office, Admin office, Faculty rooms, Two class rooms and a Library with a reading Hall.
2. The college has appointed four faculty members in all. One out of the these four faculty members, one is approved from MD University, Proceedings of the another faculty member is approved and Two other are eligible for the post of Assistant Professor of English. However, the College needs to initiate the procedure of regularisation of the faculty members as per MDU norms.
3. The college has appointed a Librarian , approved from MD University. The College Library has procured 323 books for the course The college has a DELNET membership .

Recommendations:

Keeping in view the above mentioned observations, the committee is of the opinion that the College may be granted Extension in provisional affiliation for MA English 2nd Year Course and its Continuation in 1st year course with an intake of 60 seats w.e.f the session 2023-24.
